- f) The Applicant will pay for any excessive wear or damage caused or full replacement of any lost or unreturned Hire Equipment and Motorcycles; and any legal fees resulting in the collection of goods or money.
- The Applicant/Guardian has read this document and accepts its terms and conditions;
- 8) The Applicant promises and undertakes to follow all rules, conditions, directions and signs given or shown to him/her at the event by persons referred to in 5 & 6 above and acknowledges that breach of same entitles Motorcycling Events Group Australia and/or its Partner Companies to exclude the Applicant from this and/or future events.
- 9) The Applicant/Guardian accepts the use of all Hire Equipment and/or Motorcycles and Camera-telemetry Equipment furnished to the Applicant by Motorcycling Events Group Australia "as is," with any defects, whether apparent or not. The Applicant /Guardian releases Motorcycling Events Group Australia and/or its Partner Companies and all persons described in clauses 5 & 6 above from any strict or product liability for the Applicant's injury or death or property damage to whomsoever caused.
